ELETRONIC INVOICING what is?

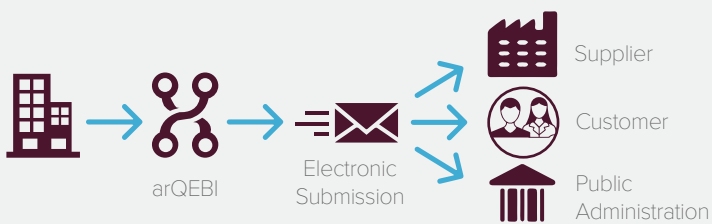
According to the EU, eletronic invoicing is "an invoice that has been issued, transmitted and received in a structured electronic format, that allows for automatic and electronic processing" (Directive 2014/55/EU).

In the future will not be enough to send a PDF invoice via email so that it is considered an electronic invoice. Electronic billing requires the creation of data in a correct structure (defined by a European standard model) and sent directly from the seller's system to the buyer.

In this way, the invoice can be automatically imported into the Public Entity's system, without the need for manual insertion.

Public and Private Entities

The rules apply to invoicing on public procurement context and therefore have an impact also on private providers. Should be reinforced that the European regulation was developed to be used by Public Administration and by Private Companies (Business - to Government, Government - to - Government and Business - to - Business).

The Community Directive explains that: "The multiplicity of non-interoperable standards gives rise to excessive complexity as well as legal uncertainty and additional operating costs for operators using electronic invoices in the Member States."

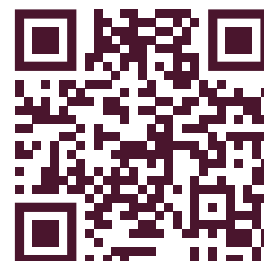
