SOLUTION

Implementation of Microsoft Dynamics AX in all of TEKA's functional areas with partner

Among the main processes implemented, which corresponded to a new paradigm in terms of the control of TEKA's operations and management, we highlight the implementation of a global solution in the area of production and supply chain management, which included physical warehouse management with mobile devices fully integrated into the operation, product traceability throughout the various production stages and the automation of data capture at shop-floor level.

Equally important was the new management of production resources through MRP which allowed for greater control of the capital invested and greater visibility over the the procurement and supply process.

Product design was also revised to allow tighter control of materials lists, with product version management and the respective life cycle, as well as the implementation of automatic approval workflows for production, which involves everything from research and development to the product's industrial manager.

The integration of the ERP with BI solutions based on the Targit tool has provided TEKA with greater ease and flexibility in data extraction and analysis, thus enabling management to analyze the information immediately and comprehensively.


